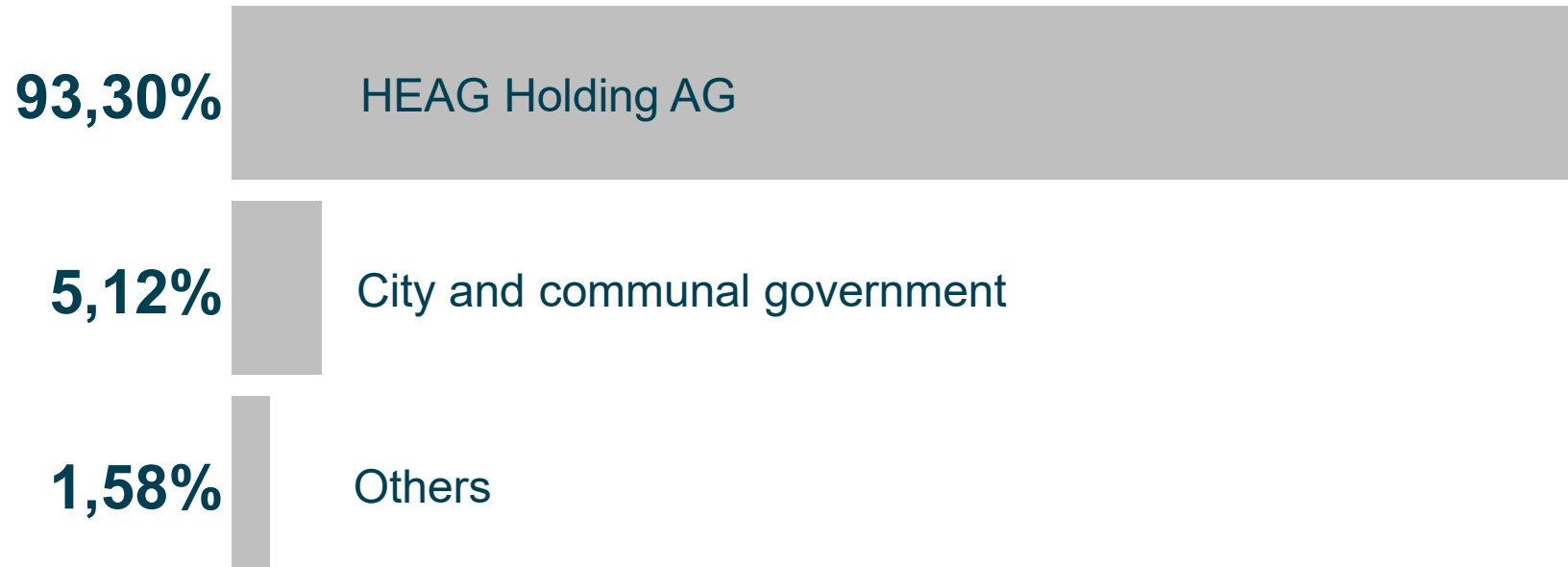

A Brief Portrait



With our subsidiaries and shareholdings we cover **the entire value-added chain of a sustainable energy supply and modern fundamental public services.**

In south Hessen we operate thousands of kilometres of **energy and drinking water networks, illuminate streets**, push **e-mobility** forward, provide **fast internet** and promote **digitalisation**. We **generate power** in renewable energy plants and in modern gas power stations. We also operate a **waste-to-energy power plant** and two **sewage plants** in Darmstadt.

We are **one of the biggest regional utilities** in Germany and are among the **leading suppliers of green electricity and carbon-neutral natural gas**. Across Germany we supply low-cost green electricity and green gas, drinking water or heat to about **680.000 customers**.

Today we can produce about 0.8 billion kWh per year ourselves. For this purpose we have invested considerable amounts **in renewable forms of energy** and gas power stations with low environmental impact. Our **renewable energy generation capacity is 289 megawatts** at present.

The ENTEGA group currently employs approx. **2,100 persons** – among them **109 trainees**.

Our Fields of Activity



Generation

Energy production with low environmental impact from renewable energy sources and from efficient gas power and heating plants. Heat supply and contracting.

Trading

Energy trading, portfolio and energy accounting management, direct marketing of power and biogas under the Renewable Energy Act.

Sales

Sales of electricity, natural gas, heat, CO₂ compensation solutions, telecommunication services and energy efficiency solutions.

Networks

Construction and operation of energy networks, land development, street lighting and traffic installations.

Operation of Public Services

Supply of drinking water, waste water treatment, burning waste, biomass and materials recycling.

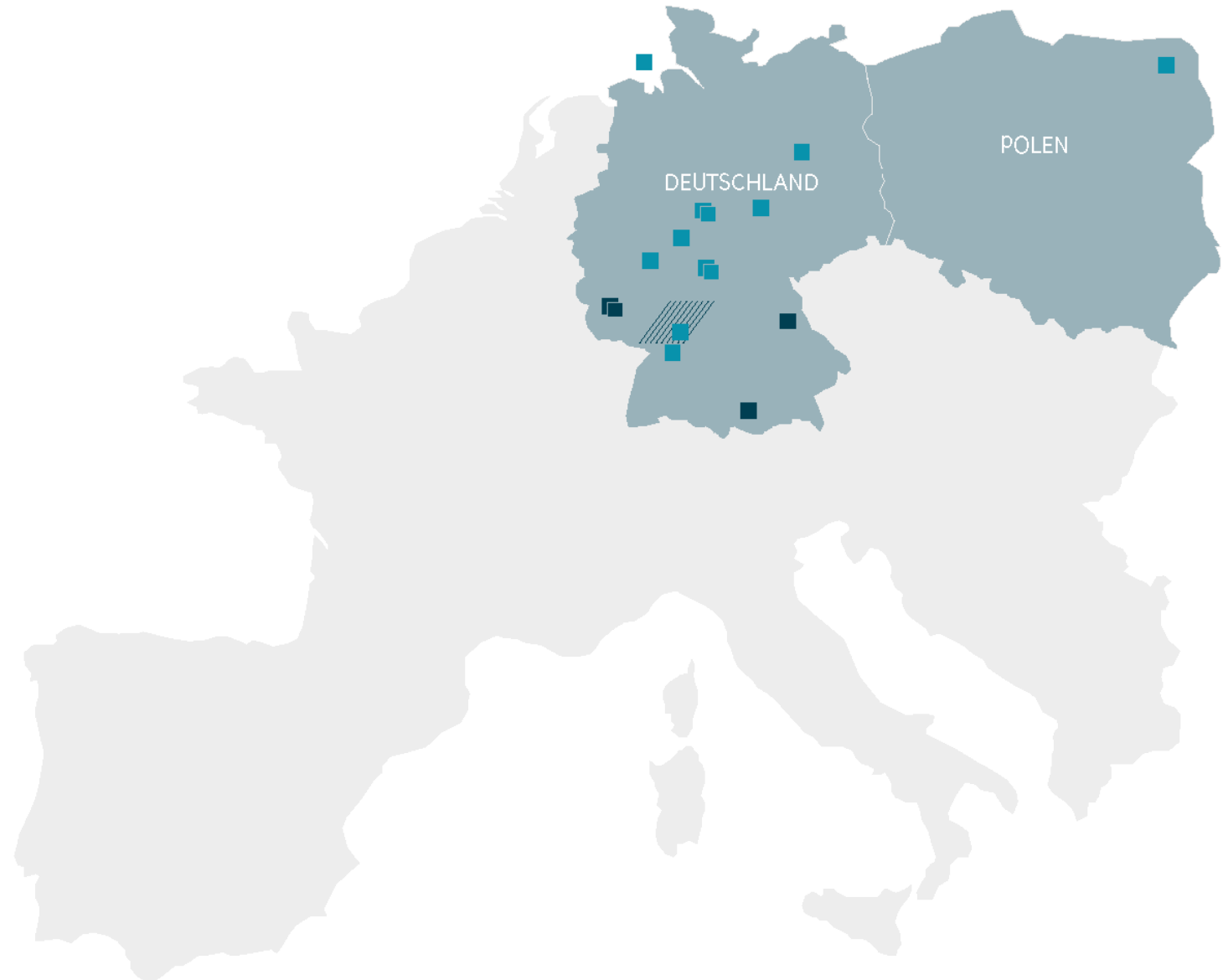

Conventional Generating Plants



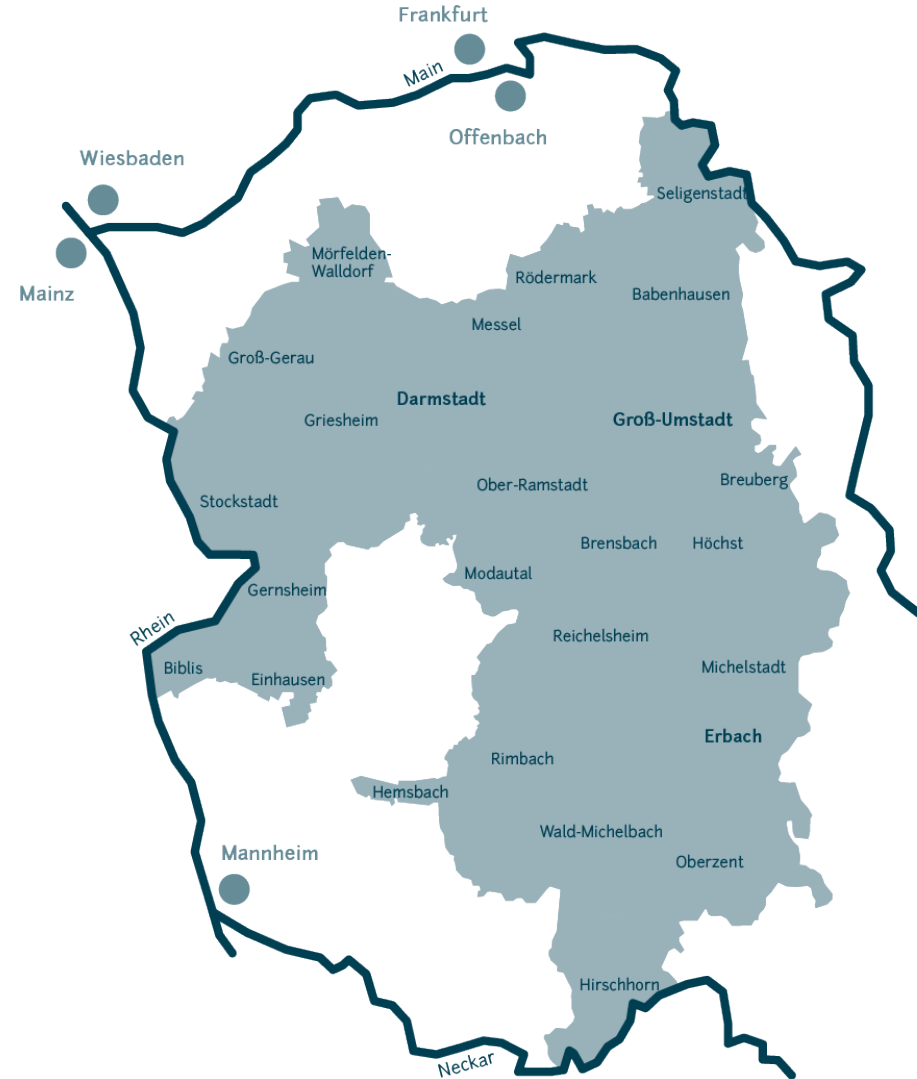
We operate two modern gas power stations, one industrial power plant, and several heat and heat & power plants in south Hesse.

As part of our **sponsoring strategy** we link our sponsoring to **ecological and social objectives**.

In addition to some **2,000 directly employed persons** in the group, in Germany **19,000 further jobs are indirectly dependent** on the activities of the ENTEGA group – approx. **5,000 in the Rhine-Main-Neckar** region.
